THIS INDENTURE, Made this 24th day of December in the year of our Lord one thousand nine hundred and thirty Between John Frederickson, a single man party of the first part, and Chas. Olin party of the second part:

WITNESSETH, That the said party of the first part, for and in consideration of the sum of Two hundred and no/100 Dollars, lawful money of the United States, to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does by these presents Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to his heirs and assigns, the following described tracts or parcels of land, lying and being in the County of Skamania and State of Washington, and particularly bounded and described as follows; to-wit:

Lots 15, 16, 17, 20 and 21 in Block 1 of Riverview Addition to the Town of Stevenson, according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington.

together with all and singular the tenements, hereditaments and appurtenances thereunto belonging.

THIS CONVEYANCE is intended as a MORTCAGE to secure the payment of 3vd Hundred and no/100 Dollars, lawful money of the United States, together with interest, thereon at the rate of Five per cent. per annum from date until paid, according to the terms and conditions of one certain promissory note, bearing date December 24th, 1930, made by the party of the first part hereto, payable on or before two years after date to the order of Chas. Olin and these presents shall be void if such payment be made according to the terms and conditions thereof. But in case default be made in the payment of the principal or interest of said promissory note, or any part thereof, when the same shall become due and payable, according to the terms and conditions thereof, then the afid party of the second part, his heirs, executors, administrators or assagns may tamediately thereafter, in the manner provided by law, foreclose this mortgage for the whole amount due upon said principal and interest, with all the other sums hereby secured.

In any suit or other proceeding which may be had for the recovery of the amount due, on either said note or this mortgage, said party of the second part, his heirs, executors; administrators or assigns shall have the right to have included in the judgment, which may be as attorneys fees, to be taxed as part recovered, the sum that the court shall adjudge reasonable of the costs in such suit as well as all payments which said party of the second part, his heirs, executors, administrators and assigns may be obliged to make for his or their security by insurance or on account of any taxes; charges, incumbrances or assessments whatsoever on the said premises or any part there-

The party of the first part agrees to keep the property insured in the sum of \$300.00, payable to the party of the second part as his interest may appear.

In case of the foreclosure of this mortgage, the party of the second part, his heirs, executors, administrators or assigns shall be entitled to have entered in such foreclosure suit a judgment for any deficiency remaining due upon account of the indebtedness secured hereby, including taxes, insurance or other lawful assessments after applying the proceeds of the sale of the premises above described to the payment thereof, and to the costs of such foreclosure suit.
