Now. THEREFORE, IT IS MUTUALLY AGREED BY SAID PARTIES, IN CONSIDERATION OF THE BENEFITS HEREBY ACCRUING TO EACH, THAT ALL PROPERTY WITHIN THE STATE OF WASHINGTON STANDING OF RECORD IN THE NAME OF EITHER OR BOTH, AND ALL PERSONAL PROPERTY NOW OWNED BY THEM IS COMMUNITY PROPERTY, AND THAT ALL OF SAID PROPERTY AND ALL COMMUNITY PROPERTY HEREAFTER ACQUIRED BY THEM SHALL, UPON THE DEATH OF EITHER PARTY HERETO, IMMEDIATELY VEST IN AND BECOME THE SOLE, SEPARATE AND ABSOLUTE PROPERTY OF THE SURVIVOR.
