This Certifies, That The Federal Land Bank of Spokene, a corporation organized and existing under the Federal Farm Loan Act, approved July 17, 1916, for and in consideration of the sum of One Dollar and other good and valuable consideration, hereby releases from the lien of that certain mortgage, executed by Sarah A. Hedrick to The Federal Land Bank of Spokene, dated June 20, 1917 and recorded in Book "%" of Mortgages on page 19, in the office of the Auditor of Skamania County, State of Washington, that part of the property covered by said mortgage, described as follows:

Commencing at spoint in the center of the Mill A Underwood Road (State Highway No. 8) 478.4 feet West of the quarter corner on the south line of Section 15, township 3 North, range 10 EWM.; running thence from a course of North 89°19' West on a 12° curve right 221.1 feet; thence North 62° 47' West 660.8 feet; thence on a 24° curve right 55 feet, more or less, to the West line of the Southeast quarter of the southwest quarter of Section 15, township 3 North, range 10 EWM., a 30 foot strip on each side of above described center line, containing .67 acres, more or less, old right of way adjacent to 30 foot strip along above described center line to revert to owner of property crossed.
