This Indenture, Made this 16th day of March in the year of our Lord one thousand nine hundred and thirty one between Mary Canoose and Ed Canoose, her husband parties of the first part, and Bank of Stevenson, a corporation, party of the second part:

Witnesseth, That the said parties of the first part, for and in consideration of the sum of Six hundred eighty five and no/100 Dollars, lawful money of the United States, to them in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do by these presents GRANT, BARGAIN, SELL, CONVEY and WARRANT unto the said party of the second part, and to its successors and assigns, the following described tracts or parcels of land, lying and being in the County of Skamania and State of Washington, and particularly bounded and described as follows; to-wit:

Lots numbered three, four, five, six and seven Block six of the Town of Stevenson, according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington, together with all rents, issues and profits from said real property from and after the 15th day of September 1931, and the right to collect the same and apply the same to reduction of principal and/or interest

together with all and singular the tenements, hereditaments and appurtenances thereunto belonging.

This Conveyance is intended as a mortgage to secure the payment of Six Hundred eighty five and no/100 Dollars lawful money of the United States, together with interest thereon at the rate of 8 per cent. per annum from date until paid, according to the terms and conditions of one certain promissory note, bearing date March 16th, 1931, made by the parties of the first part hereto, payable on or before six months after date to the order of Bank of Stevenson and these presents shall be void if such payment be made according to the terms and conditions thereof.
