COMMENCING AT THE NORTHEAST CORNER OF LOT 19 BLOCK I FIRST ADDITION TO THE TOWN OF UNDERWOOD, ACCORDING TO THE OFFICIAL PLAT THEREOF AS RECORDED AT PAGE 19 BOOK A OF PLATS, RECORDS OF SKAMANIA COUNTY, WASHINGTON; THENCE SOUTHERLY ALONG THE EASTERLY LINE OF SAID LOT 19 TO THE SOUTHEAST CORNER THEREOF; THENCE ALONG THE SOUTHERLY LINE OF SAID LOT 19 IN A WESTERLY DIRECTION 35 FEET; THENCE AT RIGHT ANGLES IN A NORTHERLY DIRECTION TO THE NORTH LINE OF SAID LOT 19; THENCE EASTERLY ALONG THE SAID NORTH LINE OF SAID LOT 19 TO THE PLACE OF BEGINNING.

OLSON PARTY OF THE FIRST PART, FOR HERSELF AND FOR HER HEIRS, EXECUTORS AND ADMINISTRATORS, DOES COVENANT WITH THE SAID PARTY OF THE SECOND PART, HIS HEIRS AND ASSIGNS, THAT THE WELL SEIZED IN FEE OF THE LANDS AND PREMISES AFORESAID, AND HAS GOOD RIGHT TO SELL AND CONVEY THE SAME IN MANNER AND FORM AFORESAID; THAT THE SAME ARE FREE FROM ALL INCUMBRANCES WHATSOEVER; THAT THE SAID LAND AND PREMISES IS HER SOLE AND SEPARATE PROPERTY; AND THE ABOVE BARGAINED AND GRANTED/PREMISES, IN THE QUIET AND PEACEFUL POSSESSION OF THE SAID PARTY OF THE SECOND PART, HIS HEIRS AND ASSIGNS, AGAINST ALL PERSONS LAWFULLY CLAIMING, OR TO CLAIM THE WHOLE OR ANY PART THEREOF, THE SAID PARTY OF THE FIRST PART WILL WARRANT AND DEFEND.
