FRED ZURCHER TO HENRY PAYROLLAZ

THIS INDENTURE WITNESSETH: THAT FRED ZURCHER, A WIDOWER, AND AT THE TIME HE ACQUIRED THE PROPERTY HEREBY CONVEYED, AN UNMARRIED MAN, OF CARSON, SKAMANIA COUNTY, WASHINGTON, PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF TEN (\$10.00) DOLLARS, LAWFUL MONEY OF THE UNITED STATES OF AMERICA, AND OTHER VALUABLE CONSIDERATIONS IN HAND PAID BY HENRY PEYROLLAZ, PARTY OF THE SECOND PART, HAS GRANTED, BARGAINED AND SOLD, AND BY THESE PRESENTS DOES HEREBY GRANT, BARGAIN, SELL AND CONVEY UNTO THE SAID PARTY OF THE SECOND PART, AND TO HIS HEIRS AND ASSIGNS, THE FOLLOWING DESCRIBED REAL PROPERTY, SITUATE, LYING AND BEING IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, PARTICULARLY DESCRIBED AS FOLLOWS, TO-WIT:

THE SOUTHWEST QUARTER (SW $\frac{1}{4}$ ) OF THE NORTHWEST QUARTER (NW $\frac{1}{4}$ ) OF SECTION TWENTY-EIGHT (28), TOWNSHIP THREE (3) NORTH OF RANGE EIGHT (8) EAST OF THE WILLAMETTE MERIDIAN; THE SOUTHEAST QUARTER (SE $\frac{1}{4}$ ) OF THE NORTHWEST QUARTER (NW $\frac{1}{4}$ ) OF SAID SECTION TWENTY-EIGHT, EXCEPTING THEREFROM A TRACT IN THE NORTHWEST CORNER THEREOF FORTY (40) RODS WIDE FROM EAST TO WEST AND THIRTY-TWO (32) RODS LONG FROM NORTH TO SOUTH, HERETOFORE DEEDED BY GRANTOR TO J. A.
