WHEREAS, the PORTLAND RAILWAY COMPANY, an Oregon corporation, as of the first day of November, 1905, made, executed and delivered to THE NEW YORK TRUST COMPANY, a corporation organized and existing under the laws of the State of New York, as Trustee, a mortgage and indenture of trust called "First and Refunding Mortgage and Deed of Trust", given to secure the payment of the principal sum of Ten Million (\$10,000,000.00) Dollars First and Refunding Mortgage Five Percent Sinking Fund Gold Bonds, together with interest thereon, the said principal sum being due and payable on the first day of November, 1930; and,
