MEMORANDUM OF AGREEMENT, MADE AND ENTERED INTO THIS ____ DAY OF JULY, 1921, BY AND BETWEEN WIND RIVER LUMBER COMPANY, A WISCONSIN CORPORATION, HEREIN REFERRED TO AS THE VENDOR, AND PERRY A. JORGENSEN, OF SKAMANIA COUNTY, WASHINGTON, HEREINAFTER REFERRED TO AS THE VENDEE,

WITNESSETH:

FIRST:- THAT THE VENDOR WILL SELL, AND THE VENDEE WILL BUY, THE FOLLOWING REAL PROPERTY LOCATED IN SKAMANIA COUNTY, WASHINGTON, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE INTERSECTION OF THE WEST BOUNDARY OF THE JOSEPH ROBBINS DONATION LAND CLAIM WITH THE SOUTH BOUNDARY OF SECTION 27, IN TOWNSHIP THREE (3) NORTH OF RANGE EIGHT (8) EAST OF WILLAMETTE MERIDIAN, AND RUNNING THENCE NORTHERLY ALONG THE WEST BOUNDARY OF SAID JOSEPH ROBBINS D.L.C. TWENTY (20) CHAINS; THEN EASTERLY AND PARALLEL TO THE SOUTH BOUNDARY OF SAID SECTION 27 TEN (10) CHAINS; THENCE SOUTHERLY AND PARALLEL TO THE WEST BOUNDARY OF SAID JOSEPH ROBBINS D.L.C. TWENTY (20) CHAINS TO THE SOUTH BOUNDARY OF SAID SECTION 27, AND THENCE WESTERLY ALONG THE SOUTH BOUNDARY OF SAID SECTION 27 TEN (10) CHAINS TO THE PLACE OF BEGINNING; SAID DESCRIBED TRACT CONTAINING TWENTY (20) ACRES, MORE OR LESS.

SUBJECT, HOWEVER, TO ALL EXISTING RIGHTS-OF-WAY OVER AND ACROSS THE SAME FOR COUNTY ROAD PURPOSES, STATE HIGHWAY PURPOSES AND THE RIGHT-OF-WAY HERETOFORE GRANTED TO SPOKANE, PORTLAND AND SEATTLE RAILWAY COMPANY, AND SUBJECT FURTHER TO
