THE NORTHEAST QUARTER (NE $\frac{1}{4}$) OF THE SOUTHWEST QUARTER (SW $\frac{1}{4}$) OF SECTION TWENTY-FOUR (24) IN TOWNSHIP TWO (2) NORTH, RANGE SIX (6) EAST WILLAMETTE MERIDIAN, IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, CONTAINING FORTY (40) ACRES MORE OR LESS, ACCORDING TO THE U.
