FOR AND IN CONSIDERATION OF THE SUM OF ONE (\$1.00) DOLLAR, RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, A RIGHT-OF-WAY IS HEREBY GRANTED TO SKAMANIA CO-OPERATIVE TELEPHONE ASSOCIATION, ITS SUCCESSORS AND ASSIGNS, WITH THE RIGHT TO ERECT AND MAINTAIN POLES, WITH THE NECESSARY WIRES AND FIXTURES THEREON, AND TO KEEP SAME FREE FROM FOLIAGE ACROSS THAT CERTAIN PROPERTY BELONGING TO HARRY HAZARD, AND SITUATED IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, AND DESCRIBED AS FOLLOWS;
