James J. Ryan and wife to Antonia DelGrosso

The Mortgagors, James J. Ryan and Mary Ryan (husband and wife) mortgage to Antonia Del Grosso to secure the payment of One Thousand (\$1000.00) Dollars lawful money of the United States, together with interest thereon at the rate of six per cent. per annum from date until paid, according to the terms and conditions of one certain promissory note bearing even date herewith made by James J. Ryan and Mary Ryan payable on or before the 31st day of August, 1936 to the order of Antonia DelGrosso the following described real estate to-wit:

Beginning at the northeast corner of the southeast quarter (SE $\frac{1}{4}$ ) of the Southwest (SW $\frac{1}{4}$ ) quarter of section three (3) in township one (1) north of range five (5) east of the Willamette Meridian, and running thence south four hundred seventy and five-tenth (470.5) feet; thence west nine hundred fifty two (952) feet to the county road; thence north along said county road to a point west of the point of beginning, and thence east eight hundred eighty five (885) feet to the point of beginning, containing ten (10) acres; excepting therefrom such portion thereof as may be appropriated by the State of Washington for highway purposes, by reason of the act of the parties of the first part heretofore performed.
