KNOW ALL MEN BY THESE PRESENTS THAT THE UNDERSIGNED, MINNIE M. GODDARD AND ELIZABETH F. GODDARD OF PORTLAND, OREGON, IN CONSIDERATION OF THE SUM OF TWO HUNDRED AND SIXTY-FIVE DOLLARS (\$265.00) TO THEM PAID BY SPOKANE, PORTLAND AND SEATTLE RAILWAY COMPANY, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAVE RELEASED AND DISCHARGED, AND DO HEREBY FOREVER RELEASE AND DISCHARGE SAID SPOKANE, PORTLAND AND SEATTLE RAILWAY COMPANY OF AND FROM ALL CLAIMS WHICH THEY HAVE OR MAY HAVE BY REASON OF DAMAGE TO THAT CERTAIN SPRING OF WATER LOCATED AT UNDERWOOD, WASHINGTON, AND FOR INTERFERENCE WITH THE FLOW OF WATER OF THE SPRING AND FOR ANY AND ALL DAMAGE TO THE RIGHTS OF THE UNDERSIGNED IN THE USE AND SALE OF THE WATERS OF SAID SPRING BY REASON OF ANY AND ALL ACTS OF THE RAILWAY COMPANY.

THE UNDERSIGNED AGREE THAT THE CONSIDERATION HEREINABOVE STATED SHALL BE ACCEPTED AND IS ACCEPTED IN FULL SATISFACTION OF ANY AND ALL DEMANDS OR CLAIMS DUE TO THE UNDERSIGNED UNDER AND BY VIRTUE OF THE PROVISIONS OF THAT CERTAIN DEED MADE AND EXECUTED OCTOBER 4, 1920, BY THE UNDERSIGNED IN FAVOR OF SPOKANE, PORTLAND AND SEATTLE RAILWAY COMPANY, AND THE UNDERSIGNED HEREBY DECLARE THAT THE PROVISIONS OF SAID DEED REQUIRING THE RAILWAY COMPANY TO PAY THE FULL AMOUNT OF DAMAGE OR LOSS RESULTING FROM INTERFERENCE WITH, INJURY OR IMPAIRMENT OF SAID SPRING OR THE FLOW OF WATER THEREFROM, ARE FULLY DISCHARGED AND SATISFIED.
