AND RUNNING THENCE SOUTH 89° 31' WEST 857.5 FEET TO A POINT IN THE CENTER OF THE STATE HIGHWAY, RUNNING THENCE SOUTH 8° 34' WEST 122.77 FEET TO THE POINT OF BEGINNING OF THE PROPERTY CONVEYED, WHICH POINT OF BEGINNING IS AT THE LOW WATER MARK OF THE WASHOUGAL RIVER AND IN THE CENTER OF SAID HIGHWAY, RUNNING THENCE NORTH 79° 4' EAST 120 FEET; THENCE SOUTH 54° 52' EAST 240.7 FEET ALONG THE LINE OF LOW WATER OF SAID WASHOUGAL RIVER, THENCE SOUTH 31° 30' WEST 399.76 FEET TO AN IRON PIPE, THENCE NORTH 87° 26' WEST 754.54 FEET TO AN IRON PIPE, THENCE NORTH 2° 34' EAST 420 FEET TO A POINT AT LOW WATER LINE ON THE SOUTH SIDE OF THE WASHOUGAL RIVER, THENCE SOUTH 87° 26' EAST 498 FEET ALONG SAID LOW WATER LINE, THENCE NORTH 79° 4' EAST 134.12 FEET. TRACING SAID LOW WATER MARK TO THE PLACE OF BEGINNING, SAVE AND EXCEPT FROM SAID PREMISES SO DESCRIBED, THE STATE HIGHWAY 60 FEET WIDE, BEING 30 FEET ON EITHER SIDE OF
