OWEN FOX ET UX BY GEORGE W. MARTIN TO THE PUBLIC

STATE OF OREGON,)
COUNTY OF MULTNOMAH.) ss.

I, GEORGE W. MARTIN BEING FIRST DULY SWORN, DEPOSE AND SAY: THAT I AM AN INHABITANT OF MULTNOMAH COUNTY, OREGON, OVER THE AGE OF 61 YEARS; THAT FOR A NUMBER OF YEARS, I WAS AN INHABITANT OF SKAMANIA COUNTY, WASHINGTON, WHERE I BECAME ACQUAINTED WITH OWEN FOX AND SARAH FOX, HIS WIFE, IN THE YEAR 1886 OR THEREABOUT, AND THAT I WAS INTIMATELY ACQUAINTED WITH BOTH FROM THAT DATE UP TO THE TIME OF THEIR RESPECTIVE DEATHS, AND BOTH ARE NOW DEAD, AND I ACTED AS ADMINISTRATOR OF THE ESTATE OF SAID OWEN FOX, DECEASED, AND I MADE INQUIRY CONCERNING THE HEIRS OF BOTH OWEN FOX AND SARAH FOX, AND FROM MY INQUIRY, I LEARNED THAT NEITHER HE OR HIS WIFE, SARAH FOX, LEFT ANY LINEAL DESCENDANTS; SARAH FOX HAVING DIED SOME YEARS PRIOR TO THE DEATH OF OWEN FOX, AND THE ESTATE OF OWEN FOX WAS DISTRIBUTED AMONG HIS COLLATERAL HEIRS AND NEXT OF KIN; THAT WHEN I BECAME ACQUAINTED WITH ^{said} OWEN FOX AND SARAH FOX, AT THE TIME ABOVE STATED, THEY WERE BOTH NEAR THE MERIDIAN OF LIFE AND ACCORDING TO MY BEST KNOWLEDGE, INFORMATION AND BELIEF, THEY HAD BEEN MARRIED FOR A NUMBER OF YEARS AND ACCORDING TO MY BEST KNOWLEDGE, INFORMATION AND BELIEF, NEITHER HAD EVER PREVIOUSLY BEEN MARRIED TO ANY OTHER PERSON. I AM INFORMED THAT ON OR ABOUT THE 11TH DAY OF JUNE, 1900, THE SAID OWEN FOX AND SARAH FOX CONVEYED TO GEORGE WACKER, THE EAST $\frac{1}{2}$ OF THE NORTHEAST $\frac{1}{2}$ OF SECTION 30, TOWNSHIP 2 NORTH, OF RANGE 5 EAST OF THE WILLAMETTE MERIDIAN, AND FROM MY LONG AND CONTINUOUS ACQUAINTANCE WITH BOTH OWEN FOX AND HIS WIFE, SARAH, I VERILY BELIEVE THAT THEY WERE HUSBAND AND WIFE, AND I KNOW, OF MY OWN KNOWLEDGE, THAT THEY WERE COMMONLY KNOWN AS HUSBAND AND WIFE AT THE DATE OF THE EXECUTION OF SAID DEED.
