CURTIS, A SINGLE MAN TO SECURE PAYMENT OF THE SUM OF TWELVE HUNDRED (\$1200.00) DOLLARS ACCORDING TO THE TERMS AND CONDITIONS OF ONE CERTAIN PROMISSORY NOTE DATED MARCH 10, 1927, DUE ONE YEAR FROM DATE, WITH INTEREST AT THE RATE OF 7% PER ANNUM, PAYABLE QUARTERLY PROMISSORY NOTE BEARING THE DATE MARCH 10, 1927, THE FOLLOWING DESCRIBED REAL ESTATE, SITUATED IN THE COUNTY OF SAKAMNIA STATE OF WASHINGTON:-

THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER (SE $\frac{1}{4}$ OF THE NW $\frac{1}{4}$ OF THE SW $\frac{1}{4}$) OF SECTION TWENTY-THREE (23), TOWNSHIP SEVEN (7) NORTH, RANGE FIVE (5) EAST OF THE WILLAMETTE PRINCIPAL MERIDIAN.
