BEGINNING AT A MAPLE TREE AT THE INTERSECTION OF THE EASTERLY LINE OF THE PRESENT COUNTY ROAD WITH THE WEST LINE OF THE NW $\frac{1}{4}$ OF THE NE $\frac{1}{4}$ SEC 34 TP 2 N R 6 E.
