THE MORTGAGORS; JAMES J. RYAN AND MARY RYAN (HUSBAND AND WIFE) MORTGAGE TO ANTONIA DEL GROSSO TO SECURE THE PAYMENT OF ELEVEN HUNDRED (\$1100.00) DOLLARS, LAWFUL MONEY OF THE UNITED STATES, TOGETHER WITH INTEREST THEREON AT THE RATE OF SIX PER CENT. PER ANNUM FROM DATE UNTIL PAID, ACCORDING TO THE TERMS AND CONDITIONS OF ONE CERTAIN PROMISSORY NOTE BEARING DATE OCTOBER 20TH, 1926 MADE BY JAMES J. RYAN AND MARY RYAN (HUSBAND AND WIFE) PAYABLE ON OR BEFORE THE 20TH DAY OF OCTOBER, 1931 IN INSTALLMENTS, TO THE ORDER OF ANTONIA DEL GROSSO THE FOLLOWING DESCRIBED REAL ESTATE;-

BEGINNING AT THE NORTHEAST CORNER OF THE SOUTHEAST QUARTER OF THE SOUTH-WEST QUARTER (SE $\frac{1}{4}$  OF SW $\frac{1}{4}$ ) OF SECTION THREE (3) IN TOWNSHIP ONE (1) NORTH OF RANGE FIVE (5) EAST OF THE WILLAMETTE MERIDIAN, AND RUNNING THENCE SOUTH FOUR HUNDRED SEVENTY AND FIVE-TENTH (470.5) FEET; THENCE WEST NINE HUNDRED FIFTY TWO (952) FEET TO THE COUNTY ROAD; THENCE NORTHERLY ALONG SAID COUNTY ROAD TO A POINT WEST OF THE POINT OF BEGINNING,
