I, GERHARDINE JANSEN, HAVING BEEN FIRST DULY SWORN, SAY:
THAT I AM THE WIDOW OF JOHN JANSEN, WHO DIED ON OR ABOUT THE 18TH DAY OF APRIL, 1916, AT MORO, SHERMAN COUNTY, OREGON;
THAT AT THE TIME OF HIS DEATH, HE AND MYSELF WERE THE OWNERS OF THE FOLLOWING COMMUNITY PROPERTY IN SKAMANIA COUNTY, STATE OF WASHINGTON:
LOTS THREE AND FOUR AND THE EAST HALF OF THE NORTHWEST QUARTER, SECTION THIRTY, TOWNSHIP THREE NORTH, RANGE NINE EAST OF THE WILLAMETTE MERIDIAN;
THAT THE SOLE HEIRS OF SAID JOHN JANSEN WERE THIS AFFIANT AND HENRY JANSEN, A SON; MARY JANSEN, A DAUGHTER; AND JOHN JANSEN, A SON;
