THE WEST $\frac{1}{2}$ OF THE SW $\frac{1}{4}$ OF THE NE $\frac{1}{4}$ AND S $\frac{1}{2}$ OF SE $\frac{1}{4}$ OF NW $\frac{1}{4}$ IN SECTION 26 TOWNSHIP NO 3 NORTH OF RANGE 7 EAST OF W.M. AND CONTAINING FOURTY ACRES
