GEORGE W. DURGIN ET AL TO THE PUBLIC

STATE OF WASHINGTON,)
COUNTY OF CLARKE.) ss.

I, FRED W. BIER, BEING FIRST DULY SWORN ON OATH DEPOSES AND SAYS THAT HE WAS WELL AND INTIMATELY ACQUAINTED WITH GEORGE W. DURGIN IN HIS LIFE TIME AND WAS ACQUAINTED WITH HIM FROM PRIOR TO 1869 TO 1880; THAT THE SAID GEO. W. DURGAN WAS A HALF BROTHER OF JOSEPH E. C. DURGAN; THAT THERE WERE SEVERAL BROTHERS OR HALF BROTHERS OF THE FAMILY; THAT ALL THE BROTHERS, EXCEPT THE SAID GEORGE W. DURGIN, SPELLED THEIR SUR NAME "DURGAN" BUT THAT HE SPELLED HIS NAME "DURGIN" FROM SOME CAUSE NOT KNOWN TO AFFIANT; THAT MANY PEOPLE AND IN FACT MOST PEOPLE IN WRITING THE NAME OR SPELLING IT SPELLED IT "DURGAN" THAT THE PERSON WHO APPEARS FROM THE RECORD TO HAVE BOUGHT LAND FROM J. E. C. DURGAN AND WIFE CATHERINE F. DURGAN, UNDER DATE OF DEC. 27, 1869 WAS GEORGE W. DURGAN AND THE SAME PERSON WHO AGAIN SOLD THE SAME TRACT BACK TO J. E. C. DURGAN UNDER THE NAME OF "DURGIN"; THAT NO OTHER PERSON WAS KNOWN IN THE COUNTY AT THAT TIME BY THE NAME OF GEO. W. DURGAN OR DURGIN, AND THAT HE WAS ONE AND THE SAME PERSON.
