Know All Men By These Presents, That Spencer Biddle, in consideration of the sum of Five Hundred and no/100 Dollars to be credited upon the indebtedness secured by the hereinafter described mortgage, does hereby RELEASE and DISCHARGE from the terms of that certain mortgage dated the 23rd day of October, 1928, and recorded on the 26th day of October, 1928, at page 332 Book "S" of Mortgages, and re-recorded on November 3rd, 1928, in Volume "S" Page 337 records of Skamania County, Washington, wherein Beacon Lake Corporation, a Washington corporation, is mortgagor and Spencer Biddle is mortgagee, the following described part of the real property therein mortgaged, to-wit:
