payment in the administration of his trust.

- 13. The mortgagee shall not be required to institute nor defend any suit, action or proceeding respecting this mortgage, or arising or growing out of his trusteeship, or of or concerning said mortgaged property or any part thereof, or the business or affairs of said mortgagor unless and until he shall have been indemnified to his satisfaction.
- 14. Any assignment, conveyance or transfer by the mortgagee of this mortgage or of any trust property that may come into the hands of the mortgagee by reason or on account of the same by foreckosure or otherwise shall be without warranty or other covenants, and subject to all liens, defects of title and encumbrances of whatsoever nature existing against said trust property at the time of such conveyance.
- 15. When said indebtedness and any renewals or extensions thereof, and the proper expenses of the mortgagee including a reasonable compensation shall fully be paid, the mortgagee shall upon demand and at the cost of the mortgagor, or its assigns, satisfy and discharge said mortgage.
- 16. Each and all of the covenants and undertakings herein contained shall apply to and bind, and may be availed of by the heirs, representatives, successors and assigns, respectively, of the mortgagor and mortgagee.
