M., running thence north to State Road as of November 5th, 1907, (the same now being a County Road) thence along said State Road, now County Road in an easterly direction to a creek about 4 chains; thence following said creek down stream in a southeasterly direction to the south line of said North East quarter of North east quarter of said section 34; thence west on said line to place of beginning, containing one and one fourth acres more or less.

Also: Beginning at the corner common to Sections 26, 27, 34 and 35 in Twp., 2 N. R. 6 E. W. M.; thence south var., 21- 30' E. 20 chains; thence West var., 21- 30' E 11.50 chains to center of creek where stake is set on bank of creek from which corner bears west 38 links; thence following center of creek for boundary line S. 54° East 2.07 chains; thence south 58° East 6.72 chains; thence south 20° east 3.42 chains to corner in center of creek at edge of S.
