Skamania Co. Abst. & Title Co. to Myrtle Attwell.

This indenture, made and entered into this 1st day of January 1932 by and between Skamania County Abstract and Title Company, a corporation, party of the first part and Myrtle Attwell party of the second part, witnesseth:

That the said party of the first part, for and in consideration of the sum of Seventeen hundred and fifty and no/100 (\$1750.00) dollars to it in hand paid by the said party of the second part, the receipt whereof is confessed does hereby grant, bargain, sell and convey unto the said party of the second part the following described real property in Skamania County, Washington, to-wit:

beginning at the northeast corner of Lot one (1) in Block eight (8) of the original plat of Stevenson, thence S 55° 30' W 106.5 feet, thence N. 34° 30' W 31.2 feet, thence N 55° 30' E 106.5 feet, thence S 34° 30' E 31.2 feet to the place of beginning, together with all appurtenances thereunto belonging.

This Conveyance is intended as a Mortgage to secure the payment of the sum of Seventeen Hundred fifty and no/100 Dollars (\$1750.00) together with interest thereon at the rate of eight per cent per annum, payable semi-annually, according to the terms and conditions of one certain promissory note bearing even date herewith payable on or before two years after date to the order of Myrtle Attwell, and these presents shall be void if such payment be made according to the terms and conditions thereof. But in case default be made in the payment of the principal or interest of said promissory note, or any part thereof, when the same shall become due and payable according to the terms and conditions thereon then the said party of the second part, her heirs, executors, administrators or assigns may immediately thereafter, in the manner provided by law, foreclose this mortgage for the whole amount due upon said principal and interest, with all other sums hereby secured.
