THAT H. M. FRENCH WAS HERETOFORE ON THE 18th DAY OF JULY, 1913, DULY AND REGULARLY APPOINTED AS THE GURRDIAN OF THE SAID FRANK M. SEELEY AND THAT AT ALL TIMES SINCE HAS BEEN THE REGULAR GUARDIAN OF SAID INSANE PERSON.

THE COURT FINDS THAT THE SAID H. M. FRENCH, AS SUCH GUARDIAN HAS TAKEN INTO HIS CHARGE AND POSSESSION THE PROPERTY SET FORTH AND ENUMERATED IN HIS FINAL REPORT HEREIN.

THAT SINCE HIS APPOINTMENT HE HAS RECEIVED THE SUM OF \$1373.00 BELONGING TO SAID ESTATE AND THAT HE HAS EXPENDED IN THE CONDUCT OF SAID ESTATE AND IN SUPPORT OF SAID INSANE PERSON THE SUM OF \$463.55, LEAVING THE SUM NOW ON HAND OF \$909.45, OF WHICH SUM THERE IS \$800.00 ON TIME DEPOSIT IN THE CITIZENS' STATE BANK OF PROSSER WASHINGTON.

THAT SAID GUARDIAN IN LOOKING AFTER SAID ESTATE EXPENDED OUT OF HIS
OWN FUNDS THE SUM OF \$24.35 AND THE COURT HEREBY AUTHORIZES HIM TO WRITE A CHECK
ON THE FUNDS OF SAID ESTATE TO REPAY HIMSELF FOR THE MONEYS SO SPENT.

AND THE COURT, AFTER DUE EXAMINATION OF SAID GUARDIAN, FINDING THAT SAID ESTATE HAS BEEN CONDUCTED IN A LEGAL AND PROPER MANNER AND THAT SAID GUARDIAN HAS EMPLOYED MCGREGOR AND FRISTOE TO REPRESENT HIM AS HIS ATTORNEYS IN THIS MATTER;

GENERAL GUARDIAN OF THE PERSON AND ESTATE OF SAID FRANK M. SEELEY, AND THE CLERK OF THIS COURT IS HEREBY AUTHORIZED TO ISSUE TO HIM LETTERS OF GUARDIANSHIP UPON HIS FILING IN THIS COURT A GOOD AND SUFFICIENT BOND IN THE PENAL SUM OF \$8000.00; AND THE SAID H. M. FRENCH IS HEREBY AUTHORIZED AND DIRECTED TO SURRENDER AND DELIVER TO THE SAID HENRY OLDENSTADT ALL OF THE PROPERTY BELONGING TO THE SAID FRANK M. SEELEY, UPON THE FILING OF THE BOND BY THE SAID HENRY OLDENSTADT, AS AFORESAID.
