This Partial release of Mortgage made and executed this 6th day of January, 1932, by Harris Trust and Savings Bank, a corporation of the State of Illinois, and Howard W. Fenton of the City of Chicago, county of Cook, in the State of Illinois, (hereinafter called the Trustees), unto Northwestern Electric Company, a corporation of the State of Washington, (hereinafter called the Mortgagor),

Witnesseth: That Whereas under date of May 1, 1915, the Mortgagor executed and delivered to the Trustees a certain mortgage, which was recorded among other places in the office of the Auditor of Skamania county, State of Washington, in volume or Book M of Mortgages, at page 576; and
