CERTIFICATE OF DISSOLUTION

TO ALL TO WHOM THESE PRESENTS MAY COME, GREETING:

KNOW YE, THAT WHEREAS, HOOD RIVER STATE BANK A CORPORATION, ORGANIZED AND EXISTING UNDER AND PURSUANT TO THE LAWS OF THE STATE OF OREGON, WITH ITS PRINCIPAL OFFICE AT NO. . . STREET, IN THE CITY OF HOOD RIVER, IN THE COUNTY OF HOOD RIVER, STATE OF OREGON, DID ON THE EIGHTEENTH DAY OF MAY, 1917, FURNISH IN DUE FORM AND FILE IN THE OFFICE OF THE SUPERINTENDENT OF BANKS OF THE STATE OF OREGON, A CERTIFICATE AND STATEMENT, DULY VERIFIED BY THE SECRETARY OF SAID CORPORATION, AND A DULY AUTHENTICATED COPY OF THE RESOLUTION ADOPTED BY A MAJORITY VOTE OF THE STOCKHOLDERS OF SAID CORPORATION AT A MEETING CALLED FOR THE PURPOSE OF AUTHORIZING THE DISSOLUTION OF SUCH CORPORATION AND THE SETTLING OF ITS BUSINESS AND DISPOSING OF ITS PROPERTY, ETC., HAS PAID THE FILING FEE, AND HAS COMPLIED WITH THE REQUIREMENTS OF CHAPTER 238 OF THE GENERAL LAWS OF OREGON FOR 1913, PROVIDING FOR THE DISSOLUTION OF PRIVATE CORPORATIONS, PRELIMINARY TO THE ISSUING OF THIS CERTIFICATE OF DISSOLUTION.

AND KNOW YE FURTHER, THAT SAID CORPORATION DID ON THE EIGHTEENTH DAY OF MAY, 1917, FURNISH IN DUE FORM AND FILE IN THE OFFICE OF THE CORPORATION COMMISSIONER OF THE STATE OF OREGON, A CERTIFICATE AND STATEMENT DULY VERIFIED BY THE SECRETARY OF SAID CORPORATION, AND A DULY AUTHENTICATED COPY OF THE RESOLUTIONS ADOPTED BY A MAJORITY VOTE OF THE DIRECTORS OF SAID CORPORATION AUTHORIZING THE DISSOLUTION OF SUCH CORPORATION IN CONFORMITY WITH THE PROVISIONS OF THE SAID CHAPTER 238, GENERAL LAWS OF OREGON, FOR 1913;
