ARTICLE FIRST.

THE NAME ASSUMED BY THIS CORPORATION AND BY WHICH IT SHALL BE KNOWN IS THE WHITE SALMON LUMBERING COMPANY; AND ITS DURATION SHALL BE UNLIMITED.

ARTICLE SECOND.

THE ENTERPRISE BUSINESS PURSUIT AND OCCUPATION IN WHICH THIS CORPORATION PROPOSES TO ENGAGE IS TO BUILD ERECT CONSTRUCT AND EQUIP AND BUY AND SELL AND HOLD AND OWN AND CARRY ON RUN OPERATE CONDUCT AND MAINTAIN SAW MILLS AND MAKE MANUFACTURE AND SELL LUMBER AND BUILDING MATERIALS AND CARRY ON A GENERAL SAW MILL BUSINESS IN THE STATE OF OREGON AND TERRITORY OF WASHINGTON, AND TO GET OUT CUT MAKE AND MANUFACTURE LOGS AND TIMBER AND BUY AND SELL THE SAME AND CARRY ON THE BUSINESS OF LOGGING, AND TO GET OUT CUT AND MANUFACTURE AND BUY AND SELL WOOD, AND TO BUILD BUY LEASE CONSTRUCT EQUIP CARRY ON OPERATE AND MAINTAIN ROADS TRACKS RUNWAYS SKIDS CHUTES AND FLUMES FOR LOGGING AND GETTING OUT WOOD AND TIMBER, AND TO BUILD BUY CONSTRUCT EQUIP OWN RUN AND NAVIGATE BOATS BARGES AND OTHER WATER CRAFT IN CONNECTION WITH THE GETTING OUT MANUFACTURING TRANSPORTING AND MARKETING OF LUMBER TIMBER LOGS AND WOOD, AND TO BUY AND SELL PURCHASE LEASE ACQUIRE HOLD AND OWN TIMBER LANDS AND TIMBER RIGHTS, AND TO PURCHASE BUY LEASE RENT ACQUIRE AND RECEIVE AND HOLD OWN AND USE REAL ESTATE WATER RIGHTS, PRIVILEGES FRANCHISES AND RIGHTS OF WAY AND TO SELL AND DISPOSE OF AND CONVEY THE SAME AND TO BUY AND SELL AND HOLD OWN AND ENJOY PERSONAL PROPERTY, AND TO BUILD CONSTRUCT KEEP AND MAINTAIN AND USE DITCHES PIPES RACES AND FLUMES FOR CONDUCTING AND CARRYING WATER FOR POWER PURPOSES, AND TO DO ALL OTHER ACTS AND THINGS NECESSARY OR CONVENIENT TO BE DONE IN CARRYING ON MANAGING AND CONDUCTING THE BUSINESS IN WHICH THIS CORPORATION PROPOSES TO ENGAGE AND IN CARRYING OUT THE OBJECTS FOR WHICH IT IS FORMED.

ARTICLE THIRD.

THE PRINCIPAL OFFICE AND PLACE OF BUSINESS OF THIS CORPORATION SHALL BE AT THE CITY OF PORTLAND IN THE COUNTY OF MULTNOMAH STATE OF OREGON.

ARTICLE FIFTH

THE AMOUNT OF EACH SHARE OF THE CAPITAL STOCK OF THIS CORPORATION IS ONE HUNDRED DOLLARS.
