KNOW ALL MEN BY THESE PRESENTS, THAT WE, CASSIUS M. VINTON (SOMETIMES KNOWN AS C. M. VINTON SO NAMED AS GRANTEE OF ONE OF THE TRACTS OF LAND HEREIN DESCRIBED) AND CAROLINE VINTON, HUSBAND AND WIFE, OF SKAMANIA COUNTY, STATE OF WASHINGTON, IN CONSIDERATION OF SEVEN THOUSAND (\$7,000.00) DOLLARS, TO US PAID BY WILLIAM E. WHITE OF SAID PLACE, HAVE BARGAINED AND SOLD, AND BY THESE PRESENTS DO GRANT, BARGAIN, SELL AND CONVEY UNTO SAID WILLIAM E. WHITE HIS HEIRS AND ASSIGNS, ALL THE FOLLOWING BOUNDED AND DESCRIBED REAL PROPERTY, SITUATED IN THE COUNTY OF SKAMANIA AND STATE OF WASHINGTON:
