to the center line of the dam of said intake; thence west 90° a distance of 243 feet; thence south $7^{\circ}34'$ west 393 feet; thence south $71^{\circ}46'$ east a distance of 236 feet; thence north $18^{\circ}14'$ east 500 feet; thence west 90° a distance of 132 feet to the point of beginning, containing 3.28 acres, more or less, together with a right at all times for a proper ingress and egress thereto and therefrom through gates properly constructed and maintained at the expense of the predecessor in title of the Company.

(68) That certain tract or parcel of land situate, lying and being in said Umatilla County, bounded and described as follows:

Beginning at the center of section twenty-six (26), township five (5) north, range thirty-six (36) east, Willamette Meridian, in said Umatilla County, and running thence north on center line of said section twenty-six (26) 650 feet to where said line intersects the center of the channel of the South Fork of the Walla Walla River; thence easterly following the center of the channel of said South Fork to where the same crosses the east line of the southwest quarter ($SW\frac{1}{4}$) of the northeast quarter ($NE\frac{1}{4}$) of said section twenty-six (26); thence south on said line to the southeast corner of said southwest quarter ($SW\frac{1}{4}$) of northeast quarter ($NE\frac{1}{4}$) of said section twenty-six (26); thence west on the half section line to the place of beginning, containing 11 acres of land; subject to the right of Albert Niebergall, Frances Niebergall and Louis Holstein to cross over said tract and over the roadway of the Company leading from its power house to the top of the mountain.

(69) That certain tract or parcel of land situate, lying and being in said Umatilla County, bounded and described as follows:

Beginning at a stake in the fence between the southwest quarter ($SW\frac{1}{4}$) and the southeast quarter ($SE\frac{1}{4}$) of section twenty-six (26), township five (5) north, range thirty-six (36) east, Willamette Meridian, in said Umatilla County, which stake is 250 feet south of the corner of the fence at the center of said section; thence south $15\frac{1}{4}^{\circ}$ west 663 feet to a stake; thence south $17\frac{1}{2}^{\circ}$ east 106 feet to a stake; thence north 32° east 269 feet to a stake at the fence between said southwest and southeast quarters; thence by said fence 516 feet to the place of beginning.

(70) That certain tract or parcel of land situate, lying and being in said Umatilla County, bounded and described as follows:

Commencing at the northwest corner of the northwest quarter ($NW\frac{1}{4}$) of the southeast quarter ($SE\frac{1}{4}$) of section twenty-six (26), township-five (5) north, range thirty-six (36) east, Willamette Meridian, and running thence east 60 rods; thence south 50 rods; thence west 60 rods; thence north 50 rods to the place of beginning, containing 19 acres, more or less.

(71) That certain tract or parcel of land situate, lying and being in said Umatilla County, bounded and described as follows:

Beginning 60 rods east and 206 feet south of the northwest corner of the southeast quarter ($SE\frac{1}{4}$) of section twenty-six (26), township five (5) north, range thirty-six (36) east, Willamette Meridian, in said Umatilla County; thence north 206 feet; thence east 296.3 feet; thence south parallel to the first above described course 539 feet; thence by direct line 445.6 feet, more or less, to the place of beginning, containing 2.53 acres.

(72) That certain tract or parcel of land situate, lying and being in said Umatilla County, bounded and described as follows:

Beginning at the quarter corner of the east side of section twenty-six (26), township five (5) north, range thirty-six (36) east, Willamette Meridian, in said Umatilla County; thence south on the east line of said section twenty-six (26) to the middle thread of the channel of the South Fork of the Walla Walla River; thence in a northwesterly direction following the middle thread of said river to a point where it crosses the north line of the northeast
