

SECTION 10 TO THE WEST LINE OF SAID SECTION 10; THENCE SOUTH ALONG THE WEST LINE OF SECTION 10 TO THE SOUTHWEST CORNER OF LOT 4 THEREIN; THENCE EAST ALONG THE SOUTH LINE OF LOTS 4 AND 5 TO THE CENTER LINE OF SECTION 15; THENCE SOUTH ALONG THE CENTER LINE OF SAID SECTION 15 TO THE CENTER THEREOF; THENCE WEST ALONG THE CENTER LINE OF SAID SECTION 15 TO THE WEST LINE OF SECTION 15; THENCE SOUTH BETWEEN SECTIONS 15 AND 16 EIGHTY RODS; THENCE WEST ALONG THE NORTH LINE OF CHENOWITH D.L.C. No. 108 TO THE NORTHWEST CORNER OF SAID CLAIM, SAID POINT BEING ON THE EAST BOUNDARY OF THE BISHOP D.L.C. No. 39; THENCE NORTH TO THE NORTHEAST CORNER OF SAID BISHOP D.L.C.; THENCE WEST ALONG THE NORTH LINE OF THE BISHOP D.L.C. TO THE NORTHWEST CORNER THEREOF; THENCE SOUTH FOLLOWING THE WEST LINE OF SAID BISHOP D.L.C. TO THE RIGHT OF WAY OF THE S. P. & S. R. R.; THENCE IN AN EASTERLY DIRECTION FOLLOWING THE NORTHERLY LINE OF THE S. P. & S. R. R. RIGHT OF WAY TO THE SOUTHWESTERLY LINE OF THE BRADFORD D.L.C. No. 37; THENCE NORTHWESTERLY ALONG THE SOUTHWESTERLY LINE OF SAID BRADFORD D.L.C. TO THE EAST LINE OF SECTION 15; THENCE NORTH BETWEEN SECTIONS 14 AND 15 TO THE QUARTER CORNER BETWEEN SAID SECTIONS; THENCE EAST ALONG THE CENTER LINE OF SECTION 14, EIGHTY RODS TO THE SOUTHEAST CORNER OF LOT No. ~~6~~ IN SAID SECTION 14, SAID POINT ALSO BEING AN INTERIOR ANGLE POINT OF THE BRADFORD D.L.C. THIS DEED IS INTENDED BY GRANTORS HEREIN TO CONVEY TO GRANTEEES HEREIN THE BUSH D.L.C. THE RITZ CLAIM, THAT PART OF THE BISHOP AND CHENOWITH D.L.C.'S LYING NORTH OF THE S. P. & S. RIGHT OF WAY AND THAT PART OF THE BRADFORD D.L.C. LYING WITHIN SECTIONS 15 IN TOWNSHIP 2 NORTH, RANGE 7 EAST OF WIL.
