Know All Men by these presents, that Mrs. Hattie J. Woodruff a widow for and in consideration of the sum of One Dollar and other valuable considerations Dollars, lawful money of the United States, to her in hand paid by Wm. Smead and Tessie Smead, his wife, the receipt whereof is hereby acknowledged, have GRANTED, BARGAINED, SOLD, ASSIGNED, TRANSFERRED, and SET OVER, and by these presents do Grant, Bargain, Sell, Assign, Transfer and Set over unto the said Wm. Smead and Tessie Smead and to their heirs and assigns, that certain Indenture of Mortgage bearing date the 10th day of April 1924 in the year of our Lord one thousand nine hundred and twenty-four made and executed by Wm. Smead and Tessie Smead as party of the first part thereto, to Mrs. Hattie J. Woodruff as party of the second part thereto, mortgaging the following described tract or parcel of land, lying and being in the County of Skamania and State of Washington, and particularly bounded and described as follows, to-wit:

North one-half of the northwest quarter of section nineteen (19) township one north of range five

The consideration for this assignment is the agreement on part of assignees to give first party good home, food, clothing and attention and nursing, shall at her death pay her funeral expenses and any bills she may leave, to bury her beside the grave of her husband.

together with all and singular the tenements, hereditaments and appurtenances thereunto belonging to secure payment of the sum of Three thousand five hundred and no/100 dollars, gold coin of the United States, together with interest thereon in like gold coin, at the rate of 7% bent per annum from 4-16-1924 until paid, according to the terms and conditions of a certain promissory note, bearing date 4-16, 1924, made by said Wm. Smead and Tessie Smead payable to the order of Hattie J. Woodruff.

And I also hereby sell, assign, transfer and set over unto them said promissory note, secured by said mortgage, and the money due and to grow due thereon.
