In the event of any litigation being instituted because of or arising out of the execution and delivery of these presents or the functioning of the Trustee as such in the manner specified in this instrument, then the Company covenants and agrees to hold the Trustee harmless of and from and to indemnify the Trustee for all of the costs, expenses and charges, including counsel fees, and all liability sustained or incurred in connection with such litigation.
