Equitable Trust Co., to Portland Trust & Savings Bank.

This Agreement made and entered into this 1st day of November, 1932, by and between Equitable Trust Company (formerly known as Lumbermens Trust Company), an Oregon corporation and Portland Trust and Savings Bank, an Oregon corporation, witnesseth:

Whereas, under date of January 1, 1924, California-Oregon Paper Mills, a California corporation, as mortgagor, made, executed and delivered a certain Trust Indenture conveying to Lumbermens Trust Company (now known as Equitable Trust Company) and Pacific-Southwest Trust and Savings Bank, as Trustees, certain property, a part of which was located in Los Angeles County, California, and a part thereof in Clark County, Washington, and a part thereof in Skamania County, Washington, and in said Trust Deed more particularly described, for the purpose of securing its First Mortgage 6½% Sinking Fund Gold Bonds in the aggregate amount of \$350,000.00, which Trust Deed was duly filed for record on the 7th day of May, 1924, and recorded in book 3113 of the Official records of Los Angeles County, California, at page 233, and was duly filed for record on May 20, 1924, and recorded in Volume 163 of the Mortgage records of Clark County, Washington, at page 1, and was duly filed for record on the 11th day of June, 1924, and recorded in Volume R of the Mortgage records of Skamania
