Whereas, under date of October 21, 1932, said John H. McNary made an appointment and designation in writing, naming Portland Trust and Savings Bank, an Oregon corporation, as Trustee under said Indenture of Trust, in lieu of and as successor to said Equitable Trust Company (formerly Lumbermens Trust Company), and a record of said appointment has been lodged in the office of said District Court of the United States for the District of Oregon; and

Whereas, said Section 12, Article VIII, of said Indenture of Trust provides that upon the making of such appointment of a successor to said original Trustee the said original Trustee shall thereupon execute to such new Trustee so ap ointed an assignment of all the rights and privileges of the original Trustee under said Trust Indenture;

Now, therefore, Equitable Trust Company hereby bargains, grants, sells, conveys and assigns unto Portland Trust and Savings Bank all its rights, title and interest in and to all of the property, real, mixed and personal, which is described in aid original Trust Indenture, together with all the rights and privileges, duties and immunities of the Trustee under said Trust Indenture, but without liability for any acts or things done or occurring prior to the date hereof; and said Portland Trust and Savings Bank hereby accepts said Trust and its appointment to said trusteeship, and agrees to serve as successor Trustee in and under said Trust Indenture, but without liability for any acts or failures to act of Equitable Trust Company with respect to its said trusteeship.
