(c) The northwest quarter of the northeast quarter of Section Four (4), Township Eighteen (18) South, Range Eleven (11) East, Willamette Meridian, subject to the reservations contained in the United States Patent to said tract, and subject to the rights of Shevlin-Hixon Company as set forth in deed dated October 22, 1919, recorded December 18, 1919, in Volume 26 at page 639 of the Deed Records of said County and Subject to the right of way in favor of City of Bend for pipe line;

(d) The northeast quarter of the northwest quarter of Section Four (4), Township Eighteen (18) South, Range Eleven (11) East, Willamette Meridian, subject to the reservations contained in the United States Patent to said tracts and subject to the right of Shevlin-Hixon Company and its successors to remove the timber on said tract at any time within thirty years from October 31, 1919;

(e) The northwest quarter of the southeast quarter of Section Six (6), Township Eighteen (18) South, Range Eleven (11) East, Willamette Meridian, subject to the reservations contained in the United States Patent to said Tract and subject to the right of Shevlin-Hixon Company and its successors to remove the timber from said tract at any time within thirty years from October 31, 1919, and subject to a right of way ^{in favor of} the City of Bend for a pipe line;

(f) The southeast quarter of the southeast quarter of Section Thirty-three (33), Township Seventeen (17) South, Range Eleven (11) East Willamette Meridian, subject to the reservations contained in the United States Patent to said tract and subject to the right of Shevlin-Hixon Company and its successors to remove the timber from said tract at any time within thirty years from October 31, 1919;

(g) A tract of land in the southeast quarter of the northeast quarter of Section One (1), Township Eighteen (18) South, Range Ten (10) East, Willamette Meridian, described as follows: A strip of land 200 feet in width, the center line of which is described as follows: Beginning at a point on the east line of said Section One (1), which point is 728 feet north of the east quarter corner of said Section One (1); thence north 82°20' west 800 feet.

(84) The following described properties and rights, situate, lying and being in said County of Deschutes, to-wit:

All the right, title and interest of the Company in and to the northwest quarter of the southwest quarter of Section Twenty-seven (27), Township Eighteen (18) South, Range Eleven (11) East, Willamette Meridian, and the southeast quarter of Section Nine (9), Township Nineteen (19) South, Range Eleven (11) East, Willamette Meridian, existing under and by virtue of the selection of said lands made by the Northern Pacific Railway Company and by mesne conveyances transferred to and vested in the Company.

(85) All of the rights of the Company, as the successor in interest of W. C. Sivyer, under and by virtue of that certain lease made and executed under date of March 5, 1913, by and between Cline Falls Power Company, an Oregon corporation, as Lessor, and said W. C. Sivyer, as Lessee, and recorded on March 3, 1917, in the Miscellaneous Records of said Deschutes County in Book 1, at page 1 thereof.

(86) The entire ice manufacturing and ice delivery business owned by the Company in and in the vicinity of the City of Bend, in said Deschutes County, including all of the Company's buildings located on that part of the northwest quarter of the northeast quarter of Section Thirty-two (32), Township Seventeen (17) South, Range Twelve (12) East, Willamette Meridian, in said Deschutes County; and including also all of the Company's machinery, apparatus, tools and appliances, all trucks and delivery equipment and all materials, supplies, stores, goods, wares and merchandise now owned and used by the Company in or in connection with its said ice manufacturing and ice delivery business.
