Know All Men by these presents that Whereas under date of April 1, 1927, Columbia River Paper Mills, a corporation organized and subsisting under the laws of the State of Washington, executed, negotiated and sold its first mortgage six per cent gold bonds in the aggregate amount of One Million Dollars (\$1,000,000) and did under the same date execute and deliver to The Bank of California, National Association, a corporation organized and existing under the banking laws of the United States, a deed of trust for the security of the said bonds, and

Whereas under date of September 20, 1932, a supplemental indenture was executed by said Columbia River Paper Mills and by The Bank of California, National Association, and

Whereas under the said supplemental indenture of date September 20, 1932, it was provided that the said supplemental indenture should not become effective until certain conditions precedent specified therein had been complied with, and

Whereas the said conditions precedent have now been complied with,
