KNOW ALL MEN BY THESE PRESENTS THAT OLIVE MAY ANDROSS AND CLAUDE ANDROSS, HER HUSBAND, PARTIES OF THE FIRST PART FOR AND IN CONSIDERATION OF THE SUM OF \$1.00 TO THEM IN HAND PAID, DO HEREBY CONVEY AND WARRANT UNTO SARAH J. MARSHALL, PARTY OF THE SECOND PART, THE FOLLOWING DESCRIBED REAL PROPERTY IN SKAMANIA COUNTY, WASHINGTON:

BEGINNING 265 (TWO HUNDRED SIXTY-FIVE FEET) FEET SOUTH AND 150 (ONE HUNDRED FIFTY) FEET WEST OF THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION (29) TWENTY-NINE TOWNSHIP (3) THREE NORTH OF RANGE (8) EIGHT EAST OF THE WILLAMETTE MERIDIAN, RUNNING THENCE WEST (50) FIFTY FEET THENCE SOUTH (100) ONE HUNDRED FEET, THENCE EAST (50) FIFTY FEET, THENCE NORTH (100) ONE HUNDRED FEET TO THE PLACE OF BEGINNING.
