THIS DEED MADE THE TWELFTH DAY OF MARCH IN THE YEAR OF OUR LORD ONE THOU-SAND NINE HUNDRED AND TWENTY-THREE BY THE NORTHERN PACIFIC RAILWAY COMPANY, A COR-PORATION OF THE STATE OF WISCONSIN, GRANTOR, TO JOHN M. BAKER OF COUGAR IN THE COUNTY OF SKAMANIA AND STATE OF WASHINGTON GRANTEE, WITNESSETH;

WHEERAS, BY A CONTRACT IN WRITING ENTERED INTO ON THE TWELFTH DAY OF MARCH, A.D. 1918. THE GRANTEE FOR THE CONSIDERATION HEREINAFTER EXPRESSED, THE PREMISES HEREINAFTER DESCRIBED, WHICH CONTRACT HAS BEEN DULY PERFORMED AND THE GRANTEE HAS BECOME ENTITLED TO A CONVEYANCE OF THE PREMISES.
