

IN THE COUNTY OF JEFFERSON, STATE OF OREGON

(87) That certain lot or parcel of land situate, lying and being in Jefferson County, State of Oregon, described as follows:

Lot Twelve (12) of Block Twenty-seven (27), Town of Culver, according to the official plat thereof on file and of record in the office of the County Clerk of said Jefferson County.

(88) That certain lot or parcel of land situate, lying and being in said Jefferson County described as follows:

Lot Twelve (12) of Block Fifty-one (51), First Addition to the Townsite of Metolius, according to the official plat thereof on file and of record in the office of the County Clerk of said Jefferson County.

(89) That certain lot or parcel of land situate, lying and being in said Jefferson County, described as follows:

Lot Eight (8) of Block Thirty-three (33), Town of Palmain (now Madras) according to the official plat thereof on file and of record in the office of the County Clerk of said Jefferson County.

IN THE COUNTY OF CROOK, STATE OF OREGON

(90) Those certain lots or parcels of land situate, lying and being in Crook County, State of Oregon, described as follows:

Lots Seven (7) and Eight (8) of Block Nine (9), and Lots One (1) Two (2), Three (3), Four (4), Five (5) and Six (6) of Block Ten (10) First Addition to the City of Prineville, according to the amended plat thereof on file and of record in the office of the County Clerk of said Crook County.

(91) That certain lot or parcel of land situate, lying and being in said Crook County, bounded and described as follows:

Beginning at a point 1120 feet north and 60 feet east from the northeast corner of Block Nine (9) of Newsom's Addition to the City of Prineville, according to the official plat thereof on file and of record in the office of the County Clerk of said Crook County; thence east 120 feet; thence north 80 feet; thence west 120 feet; thence south 80 feet to the place of beginning.

Ayers Third Addition to the City of Heppner in said Morrow County, according to the official plat thereof on file and of record in the office of the County Clerk of said Morrow County; except that portion of said Lot Two (2) of Block Three (3) bounded and described as follows: Commencing at a point on the north line of said Lot Two (2) of Block Three (3), which point is 10 feet west from the northeast corner of said Lot Two (2); thence south 10°7' west to an intersection with the south line of said Lot Two (2) at a point 20 feet west from the southeast corner of said Lot Two (2); thence west on the south line of said Lot Two (2) to the southwest corner thereof; thence north on the west line of said Lot Two (2) to the north
