(b) Lots One (1) and Two (2) of Block Four (4) in T. W. Ayers Third Addition to the City of Heppner, in said Morrow County, according to the official plat thereof on file and of record in the office of the County Clerk of said County;

(c) Lot Three (3) and the south 26 feet of Lot Four (4) of Block Three (3), in T. W. Ayers Second Addition to the City of Heppner, in said Morrow County, according to the official plat thereof on file and of record in the office of the County Clerk of said County;

(d) That certain vacated portion of the alley in Block Three (3) in T.W. Ayers Second Addition to the City of Heppner in said Morrow County, lying between Lots One (1) and Four (4) and the North 27 feet of Lots Two (2) and Three (3) of said block;

(e) All of Lot One (1) of Block Three (3) of Ayers Second Addition to the City of Heppner, in said Morrow County, (also described as Lot One (1) of Block Five (5) of Ayers Fourth Addition to the Town of Heppner), lying north and west of a straight line drawn from a point in the east line of said Lot One (1), which point is 25 feet south of the northeast corner of said lot, to a point in the south line of said lot which is 70 feet west from the southeast corner of said lot; and also all that portion of Lot Two (2) of said Block Three (3) lying north and west of a straight line extending from the southwest corner of said Lot Two (2) to a point in the north line of said Lot Two (2) which is 70 feet west of the northeast corner of said lot; except that portion of said Lots One (1) and Two (2) conveyed to said City of Heppner for a public alley.
