Whereas, Portland Trust and Savings Bank, an Oregon corporation, has been duly designated as Trustee under said Trust Indenture or Mortgage in lieu and in place of said Lumbermens Trust Company and all rights of said Lumbermens Trust Company as Trustee under and by virtue of said Trust Indenture or Mortgage and in or to property conveyed thereby have been duly assigned and transferred to said Portland Trust and Savings Bank by assignment dated the first day of November, 1932, which assignment was duly filed for record in the office of the Auditor of Clark County, Washington on the 21st day of November, 1932 and duly recorded in Volume 219 of the Mortgage records of said County at page 5 and which was also filed for record in the office of the County Auditor of Skamania County, Washington, on the 22nd day of November, 1932, and recorded in Book "T" of Mortgages of said County at page 208, and which assignment was also filed for record in the office of the County Recorder of Los Angeles County, California on November 23rd, 1932 and recorded in Book 11810 of the Official records of said County at page 376; and

Whereas, by mergers and consolidations Security-First National Bank of Los Angeles, a national banking association, has succeeded said Pacific-Southwest Trust and Savings Bank as Trustee under said Trust Indenture or Mortgage and said Supplemental Indenture; and

Whereas, said California-Oregon Paper Mills has paid and satisfied all the mortgage indebtedness secured by said Trust Indenture or Mortgage and said Supplemental Indenture and has complied with the other terms and provisions thereof and is now entitled to a release and discharge of the same.

Now, Therefore, said Portland Trust and Savings Bank and said Security-First National Bank of Los Angeles, in consideration of the premises and of the sum of Ten (\$10.00) Dollars to them in hand paid by said California-Oregon Paper Mills, do hereby release, DISCHARGE and fully SATISFY the said Trust Indenture or Mortgage and said Supplemental Indenture and do hereby reconvey to said California-Oregon Paper Mills the property covered thereby except only such part thereof as has been heretofore released and discharged from the lien of said Trust Indenture or Mortgage and said Supplemental Indenture and/or reconveyed to said California-Oregon Paper Mills.
