Harry Poston to D. Cannavina.

Partial release of mortgage.

This Indenture, made this 9th day of April, 1934, between Harry Poston of Pasadena, California, of the first part, and C. Cannavina of Skamania County, Washington, of the second part:

Whereas, the said party of the second part, by indenture of mortgage, bearing date the 13th day of April, 1933, and recorded in the office of the county auditor of Skamania County, Washington on April 17th, 1933 in Book T records of mortgages of said county at page 227, did, for the consideration and for the purposes therein mentioned, mortgage the premises therein described.

And Whereas, the said party of the second part has, in consideration of the covenants and agreements therein contained, caused a certain portion of said mortgaged premises to be platted and filed as by law required, and said first party herein has for good and sufficient consideration agreed to release said platted tracts from said mortgage.

Now, therefore, this indenture witnesseth: That the said Harry Poston for good and sufficient consideration and the covenants and agreements in said mortgage contained, does by these presents GRANT, RELEASE, QUITCLAIM and set over unto the said party of the second part, his heirs and assigns, all that part of the said mortgaged lands as shown and appears of record in the official plat of El Descanso Al Rio Tracts, said tracts being located in the NE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 15, Twp., 4 N. R. 7 E. W. M., and said official plat being of record at page 90 of Plat Book 1 of Skamania County, Washington.

Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining; and all the lien, right, title and interest of the said party of the first part, of, in and to the same, to the intent that the lands hereby conveyed and released shall forever be discharged from the said mortgage, and that the rest of the lands in the said mortgage may remain to the said party of the first part, as heretofore.

To Have and To Hold the lands and premises hereby conveyed and released, to the said party of the second part, his heirs and assigns forever.
