THIS INDENTURE WITNESSETH, THAT, WIND RIVER LUMBER COMPANY, A CORPORATION, PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF FIVE THOUSAND DOLLARS (\$5000.00) IN LAWFUL MONEY OF THE UNITED STATES OF AMERICA, TO IT IN HAND PAID BY S. RILEY COGAN, OF SKAMANIA COUNTY, WASHINGTON, PARTY OF THE SECOND PART, HAS GRANTED, BARGAINED AND SOLD, AND BY THESE PRESENTS DOES GRANT, BARGAIN, SELL AND CONVEY UNTO THE SAID PARTY OF THE SECOND PART, AND TO HIS HEIRS AND ASSIGNS THE FOLLOWING DESCRIBED REAL PROPERTY LYING AND BEING IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, TO-WIT:

ALSO, THE TIMBER ONLY ON THAT PORTION OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER (SW $\frac{1}{4}$  OF NW $\frac{1}{4}$ ) OF SECTION EIGHT (8), LYING BETWEEN THE FORKS OF PANTHER AND BEAR CREEKS, IN TOWNSHIP THREE (3) NORTH, RANGE EIGHT (8) EAST OF WILLAMETTE MERIDIAN, WITH FULL LIBERTY AND AUTHORITY UNTIL THE FIRST OF JANUARY, 1924, TO FELL, CUT DOWN AND REMOVE THE SAME;
