thence east along said north line 95 feet; thence south 20° west 242 feet more or less, to a pine tree on the north side of the county road; thence along said road to where it crosses the west line of said southwest quarter (SW $\frac{1}{4}$) of southeast quarter (SE $\frac{1}{4}$); thence north along said west line of southwest quarter (SW $\frac{1}{4}$) of southeast quarter to the middle channel of the stream of Hood River; thence northeasterly along said middle channel to the north line of said northwest quarter (NW $\frac{1}{4}$) of southeast quarter (SE $\frac{1}{4}$); thence east to the place of beginning.

(121) That certain tract of land in the northeast quarter (NE $\frac{1}{4}$) of southeast quarter (SE $\frac{1}{4}$) of section fifteen (15) township two (2) north, range ten (10) east, Willamette Meridian, in said Hood River County, bounded and described as follows:

Beginning on the east line of said section fifteen (15) where said line intersects the low water mark on the north bank of the stream of Hood River; thence south along said east line of said section fifteen (15) to a point 100 feet southerly from the high water mark on the southerly side of the stream of Hood River; thence westerly on a line 100 feet south of and parallel to the high water mark on the southerly side of Hood River to a point on the southerly line of the tract of land described in paragraph (119) above; thence along the southerly and easterly side of said tract in a northerly direction to the low water mark on the north bank of the stream of Hood River; thence easterly along said low water mark to place of beginning.

(122) That certain tract of land in the southwest (SW $\frac{1}{4}$) of section fifteen (15), township two (2) north, range ten (10) east of Willamette meridian, in said Hood River County, bounded and described as follows: Beginning at a point on the east line of the southwest quarter (SW $\frac{1}{4}$) of section fifteen (15), township two (2) north, range ten (10) East willamette Meridian 100 feet south from the high water line on the southerly bank of the stream of Hood River; thence in a general westerly direction parallel with and 100 feet southerly from said highwater line to a point on the west line of said southwest quarter (SW $\frac{1}{4}$) of section fifteen (15); thence north on said west line of said southwest quarter (SW $\frac{1}{4}$) to the center of the stream of Hood River; thence easterly along the center line of said stream to the east line of the southwest quarter (SW $\frac{1}{4}$) of southwest quarter (SW $\frac{1}{4}$) of said section fifteen (15); thence north along said subdivision line to a point 30 feet north of the center of the Company's proposed power canal or flume; thence in a general easterly direction parallel with and 30 feet northerly from said center line to an intersection with the east line of said southwest quarter (SW $\frac{1}{4}$) of section fifteen (15); thence south along said east line of said southwest quarter (SW $\frac{1}{4}$) to the place of beginning.

(123) That certain tract of land in the south half (S $\frac{1}{2}$) of southeast quarter (SE $\frac{1}{4}$) of section sixteen (16), township two (2) north, range ten (10) east, Willamette Meridian, in said Hood River County, bounded and described as follows:

All that part of the south half (S $\frac{1}{2}$) of southeast quarter (SE $\frac{1}{4}$) of section sixteen (16) lying between lines marking the high water mark on the southerly bank of the stream of Hood River and a line 100 feet northerly of the high water mark on the north bank of said stream, including the stream of Hood River and all rights of the Company in connection with the same.

(124) That certain tract of land in the northeast quarter (NE $\frac{1}{4}$) of northwest quarter (NW $\frac{1}{4}$) of section twenty-one (21), township two (2) north, range ten (10) East, Willamette Meridian, in said Hood River County, described as follows:

All the bed of the stream of Hood River from high water to high water mark on either side of said stream in the northeast quarter (NE $\frac{1}{4}$) of northwest quarter (NW $\frac{1}{4}$) of section twenty-one (21), together with all rights and privileges owned by the Company in connection therewith.
