On or before July 1, 1935, without grace, for value received, we, jointly and severally, promise to pay the Copeland Lumber Company, a corporation, or order at North Bonneville, Washington, \$1600.00, with interest from date on deferred payments at the rate of 7% per annum, interest payable July 1, 1935, and if not so paid the whole sum of both principal and interest to become immediately due and collectible, at the option of the holder of this note. If not so collected, the interest to be added to and become part of the principal and the same to bear interest thereafter, until paid, at the rate of 7% per annum. In case action is commenced to enforce payment of this note, or any portion thereof, we, jointly and severally, promise to pay such additional sum as the court may adjudge reasonable as attorneys' fees. It is especially agreed and consented to that a deficiency judgment may be taken in a suit upon this note. The installments hereinafter mentioned shall become thirty days in arrears prior to the right of the mortgagee to declare the entire amount of the note due and payable.

It is agreed that said note shall be paid as follows: July 1, 1934, \$50.00; August 1, 1934, \$50.00; September 1, 1934, \$50.00; October 1, 1934, \$50.00; November 1, 1934, \$50.00; December 1, 1934, \$50.00; that thereafter the sum of \$90.00 shall be
