KNOW ALL MEN BY THESE PRESENTS: THAT I, E. C. AMANN, TRUSTEE, IN CONSIDERATION OF THE SUM OF ONE DOLLAR (\$1) AND OTHER VALUABLE CONSIDERATIONS TO ME PAID BY GREENLEAF LUMBER COMPANY, A WASHINGTON CORPORATION, HAVE BARGAINED AND SOLD, AND BY THESE PRESENTS DO GRANT, BARGAIN, SELL AND CONVEY UNTO SAID GREENLEAF LUMBER COMPANY, ITS SUCCESSORS AND ASSIGNS, ALL OF THE RIGHT, TITLE AND INTEREST ACQUIRED BY ME, THE SAID GRANTOR, UNDER AND BY VIRTUE OF THE FORECLOSURE PROCEEDINGS IN THE DISTRICT COURT OF THE UNITED STATES FOR THE SOUTHERN DIVISION OF THE WESTERN DISTRICT OF WASHINGTON, IN THE CASE OF WILLIAM H. PUTNAM, TRUSTEE, VS. J. K. LUMBER COMPANY, A CORPORATION, FRED A. KRIBS, WILLARD N. JONES, AND TIMBER PRIVATE RAILROAD COMPANY, A CORPORATION, WHEREIN I, THE SAID GRANTOR, WAS A PURCHASER AT FORECLOSURE SALE, - IN AND TO THE FOLLOWING DESCRIBED REAL PROPERTY SITUATED IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, TO-WIT: -

TOWNSHIP TWO (2) NORTH, RANGE SIX (6) EAST:

SECTION ONE (1). ALL THE TIMBER ON LOTS ONE (1) AND TWO (2) AND THE SOUTH HALF OF THE NORTHEAST QUARTER ($S\frac{1}{2}$ OF $NE\frac{1}{4}$) WITH RIGHT TO ENTER UPON THE LAND AND REMOVE THE TIMBER AT ANY TIME WITHIN TWENTY FIVE YEARS FROM APRIL 10, 1903. LOTS THREE (3) AND FOUR (4) AND THE SOUTH HALF OF THE NORTHWEST QUARTER ($S\frac{1}{2}$ OF $NW\frac{1}{4}$) AND THE NORTH HALF OF THE SOUTH HALF ($N\frac{1}{2}$ $S\frac{1}{2}$) SUBJECT TO MINERAL RESERVATION AND RESERVATION OF RIGHT TO CARRY ON MINING OPERATIONS, ALSO RIGHT-OF-WAY FORTY (40) FEET WIDE RESERVED ACROSS THE LAND FOR A LOGGING ROAD.

SECTION TWENTY-NINE (29). THE NORTH-EAST QUARTER ($NE\frac{1}{4}$), THE WEST HALF ($W\frac{1}{2}$), THE WEST HALF OF THE SOUTHEAST QUARTER ($W\frac{1}{2}$ $SE\frac{1}{4}$) AND THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER ($SE\frac{1}{4}$ $SE\frac{1}{4}$).

SECTION THIRTY (30). THE EAST HALF ($E\frac{1}{2}$), THE EAST HALF OF THE WEST HALF ($E\frac{1}{2}$ $W\frac{1}{2}$) AND LOTS ONE (1), TWO (2) AND THREE (3).

SECTION THIRTY-ONE (31). ALL.

SECTION THIRTY-TWO (32). ALL.

TOWNSHIP TWO (2) NORTH, RANGE SEVEN (7) EAST.:

SECTION SIX (6). LOTS THREE (3), FOUR (4), FIVE (5), SIX (6) AND SEVEN (7), THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER ($SE\frac{1}{4}$ $NW\frac{1}{4}$) AND THE EAST HALF OF THE SOUTHWEST QUARTER ($E\frac{1}{2}$ $SW\frac{1}{4}$).

SECTION SEVEN (7). THE EAST HALF OF THE NORTHWEST QUARTER ($E\frac{1}{2}$ $NW\frac{1}{4}$) AND THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER ($SW\frac{1}{4}$ $SE\frac{1}{4}$).
