Lumber Company, by appointment of the United States District Court for the Southern Division of the Western District of Washington, hereinafter called the party of the second part;

WITT N.E.S S E T H:

IT IS MUTUALLY AGREED BETWEEN THE PARTIES HERETO THAT THE LOGGING RAILROAD,
