Federal Land Bank to Flora M. Hunter et vir

Partial Release of Mortgage.

This Certifies that The Federal Land Bank of Spokane, a corporation organized and existing under the Federal Farm Loan Act, approved July 17, 1916, for and in consideration of the sum of One Dollar and other good and valuable consideration, hereby RELEASES from the lien of that certain mortgage, executed by Flora May Hunter et vir to the Federal Land Bank of Spokane, dated July 17, 1925, and recorded in Book "Q" of Mortgages on page 98 in the office of the Auditor of Skamania County, State of Washington, that part of the property covered by said mortgage, described as follows:
