THE OBJECT OF THIS SUIT IS TO OBTAIN A DECREE OF ABSOLUTE DIVORCE FROM THE DEFENDANT; TO OBTAIN THE SOLE CUSTODY, CARE AND POSSESSION OF THE TWO MINOR SONS OF THE PLAINTIFF AND THE DEFENDANT, AND TO QUIET TITLE IN THE PLAINTIFF TO THE FOLLOWING DESCRIBED REAL PROPERTY, TO-WIT:
